## Certification Information

To become a PATH Certified Instructor, you must successfully complete two phases of the Registered Certification process.

The components of Phase 1 are:

- ◆ PATH Membership
- ◆ Application
- ◆ Pre-Certification Self-Assessment
- ◆ CAT Course and exam
- ◆ Instructor Self-Study and Open Book Exam
- ◆ Complete the Horsemanship Skills Checklist
- ◆ Adult/Child CPR and First Aid

Completion of Phase 1 is mandatory before beginning Phase 2. Once you have successfully completed Phase 1, you will receive a confirmation letter of your Instructor-in-Training (IT) status, which is valid for 12 months. Phase 2 must be completed within the 12 months of receiving your IT confirmation letter.

The components for Phase 2 are:

- ◆ Complete Phase 2 Candidate Forms
- ◆ Complete 25 hours of practice teaching mounted group therapeutic riding lessons under the guidance or direct supervision of a PATH Certified Instructor
- ◆ Attend a Registered Instructor Workshop and Certification (may be completed separately or together)
- ◆ Successfully complete the Registered Instructor On-Site Certification.

## Registration Information

Candidates are registered on a first-come, first-served basis, so be sure to register early. All Candidates MUST register 32 days prior to the Registered Certification.

Once you have registered, we will send you a Phase 2 Packet. To participate in Certification, complete the Phase 2 packet and return it to Giant Steps with a copy of your PATH membership card, and current copies of your CPR & First Aid Registered Certification.

DEADLINE for registration: July 12, 2016.

CANCELLATIONS POLICY: Cancellations prior to the registration deadline (July 12, 2016) will be refunded less \$150 of your total registration fee. No refunds will be issued after July 12, 2016.
